Effective from March 09, 2020 – following change in the Existing Clause "Current Level of Management Fee" in Annexure (A) of the offering document of HBL Islamic Equity Fund is amended and now read as follows:

Management Fee

The maximum limit of management fee is 3.00% per annum of Average Annual Net Assets.

The current level of management fee shall be disclosed in monthly Fund Manager Report (FMR)
